Chapter 107 COUNTY BOARD

Sec. 107.01. The County Board of Legislators; general powers.

The legislative body of Westchester County shall be known as the County Board of Legislators and, except as otherwise provided by law, shall be vested with all the powers and duties of the county and with all the powers and duties which now are, or may hereafter be, conferred or imposed by law on boards of supervisors or other governing bodies of counties. Wherever the term "County Board" or "Board of Supervisors" appears in any provisions of this act or of the Westchester County Administrative Code, it shall be deemed to mean and refer to the County Board of Legislators.

Sec. 107.11. Members: term, vacancies, vote.

- 1. The County Board of Legislators shall consist of such number of members elected from each County Board district as shall be set forth in section 107.31 of this act. The term of office of members of the County Board shall be two years and shall begin on the first day of January next following their election. Members of the County Board shall be known as county legislators and shall be county officers.
 - 2. a. Whenever a vacancy in the office of County Legislator shall occur within a year in which there is no County-wide general election for the position of County Legislator, or on January 1 of a year in which there is a County-wide general election for the position of County Legislator, such office shall be filled for the remainder of the unexpired term at a special election in the legislative district of said vacated office, to be called by the County Board as soon as practicable and, in any event, to be held no later than 90 days from the date of such vacancy. Notice of a special election called hereunder shall be in the manner provided for in the Election Law for notice of a general election. To the maximum extent feasible, the provisions of the Election Law governing the conduct of a special election shall apply. It shall be the duty of the Board of Elections to prepare ballots, voting machines and other matters so that such election may be properly held and conducted. Notwithstanding any law to the contrary, the expenses of a special election conducted pursuant to this law shall be borne by the county.
 - b. Whenever a vacancy in the office of County Legislator occurs after January 1 of a year in which there is a County-wide general election for the office of County Legislator such vacancy may be filled by an appointment made by the remaining members of the board of an individual otherwise qualified to hold such office. The appointee shall serve as County Legislator until an individual is certified by the Board of Elections to be County Legislator-elect for that legislative district as a result of the general election scheduled in November. Upon such certification, the County Legislator-elect shall take office and thereby shall replace the appointee, if any, for the remainder of the unexpired term. The determination of the Board of Legislators as to an appointee's qualification or forfeiture of office shall be conclusive.
- 3. Each County Legislator shall be entitled to one vote. Except as otherwise expressly provided in this act or in the Local Finance Law, action of the County Board shall be by a majority vote of all members of the board, provided that a vote to adjourn or to take action regarding the attendance of absent members may be taken by a majority of the members present.
- 4. No person shall serve as a member of the County Board for more than six consecutive two-year terms. The first year for any County Legislator for the purposes of calculating years as contained in this section shall

commence on or after January 1, 2012. No service for a partial term as a County Legislator shall be included in calculating the six consecutive two-year terms.

Sec. 107.21. Specific powers.

In pursuance of and in addition to all powers specified in the preceding section, the County Board shall have power, subject to the provisions of this act, to:

- 1. Create, organize, alter or abolish departments, commissions, boards, bureaus, offices and employments and/or transfer their functions and duties;
- 2. Exercise all powers of local legislation and administration as provided for counties in Article 9 of the Constitution of the State of New York;
- 3. Provide by act for the compensation of appointive officers and employees;
- 4. Fix the number of deputies, assistants, clerks and other persons to be employed in the several departments, offices and commissions of the county;
- 5. Provide for the creation of offices other than those required by the constitution and laws of the state, and by this act;
- 6. Provide for officers hereafter created by law or for the allocation of their duties to existing officers;
- 7. Provide for the assumption and discharge by county officers of such functions of cities, towns, villages and special districts as may devolve on the county by this act or by contract or by transfer or be conferred otherwise by law;
- 8. Fix the amount of all bonds and approve the sureties of all county elective and appointive officers and county employees;
- 9. Employ such legal, financial or other technical advisers as may be necessary from time to time, in relation to the performance of any of the functions of county government;
- Enact such acts and make such reasonable rules and regulations as may be necessary and proper to carry out the provisions of this act and of general law applicable to the county, and provide for the enforcement of such acts by appropriate penalties;
- 11. Make appropriations, levy taxes and, except as otherwise provided by the Local Finance Law, incur indebtedness for the purpose of carrying out any of the powers and duties conferred or imposed on the county or any officer, department, board, commission or other authority thereof, by this act or otherwise by law;
- 12. Investigate the official conduct and the accounts, receipts, disbursements, bills and affairs of any office or officer of the county, or of any office or officer of any special county district or other unit of county government, and make such studies or investigations as it deems to be in the best interests of the county, and for such purposes may subpoena witnesses, administer oaths and require the production of books, papers and other evidence, subject to the exclusive procedure for the issuance of subpoenas by the County Board of Legislators or any of its committees as explicitly set forth in the Rules of the County Board of Legislators. In case any person fails or refuses to obey any such subpoena, he shall be guilty of a misdemeanor, and subject to such penalties as the County Board, by act, may prescribe;
- 13. Determine and make provision for any matter of county government not otherwise provided for, including any matter involved in transition to the form of government provided by this act.

Sec. 107.31. County Board districts: nomination and election of members; number and qualification of members.

- For the purpose of electing county legislators, the County of Westchester shall be divided into 17 districts, from each of which one county legislator shall be elected. Nominations for the office of county legislator shall be made at the primary election held in the respective districts from which they are to be elected in the same manner as other county officers are nominated in accordance with the provisions of the election law.
- 2. County Board districts are described by municipalities, census tracts, census block groups, and census blocks as defined by the United States Census Bureau.

- 3. Each county legislator shall be an elector of the county and a resident of the district from which he is elected. A county legislator who ceases to be a resident of such district from which he is elected shall forfeit his office and the same shall be deemed vacant, except as provided in subsection 6. of this section.
- 4. A county legislator shall not hold any other salaried or elective public office during his tenure.
- 5. County legislators shall be elected at the general election held in each odd-numbered year.
- 6. The County Board shall, if necessary, after each decennial federal census, adopt a local law amending subsections 1. and 2. of this section, as appropriate, to prescribe County Board districts. Such local law shall comply with the legal requirements for equal representation, the New York State Municipal Home Rule Law, and the John R. Lewis Voting Rights Act of New York.
- 7. No member of the County Board shall be required to vacate his office by reason of any change in the boundary lines of his County Board district made during his term.

Sec. 107.61. Procedure; rules.

The board shall keep a journal of its proceedings. It shall establish rules for its proceedings, including rules for the appointment of all committees and for compelling the attendance of all absent members, not inconsistent with the provisions of this act or of general law or with the following specific provisions:

- 1. The County Board shall proceed only by local law, act or resolution. Local laws, acts and resolutions except motions for adjournment shall be introduced only in written or printed form. All acts, except acts making appropriations and acts codifying or rearranging existing acts or resolutions or enacting a code of laws, shall be confined to one subject, and the subject or subjects of all acts shall be clearly expressed in the title. Acts making appropriations shall be confined to the subject of appropriations. No money shall be appropriated, bond issue or other loan authorized, tax or assessment levied, office created, salary fixed, franchise or privilege granted, real property of the county sold, ordinance adopted, fine or penalty established, except by act.
- Except as otherwise provided by this chapter or by Chapter 852 of the Laws of 1948, known as the
 Westchester County Administrative Code, as amended, or as otherwise provided by the Local Finance
 Law or other statute, no local law, act or resolution, except resolutions relating to procedure, shall be
 passed by the board by less than a majority of all members of the board. The yeas and nays shall be

taken upon the passage of all local laws, acts and resolutions which involve or might involve the expenditure of money and entered upon the journal of the proceedings of the board. All local laws, resolutions, acts and other measures filed with the board shall be open to public inspection at all times during which the office of the Clerk of the County Board shall be open.

3. Whenever the term "two-thirds" is used in this Act with regard to any vote of the County Board it shall mean 12 members of the entire County Board consisting of 17 members.

No act shall take effect until the same has received the written approval of the County Executive; provided that, if any act is not returned to the County Board by the County Executive with a statement in writing of his reasons for not approving the same within ten days of its presentation to him by the board, such act shall be deemed approved; and provided, further, that any act disapproved by the County Executive, shall nevertheless become effective if upon reconsideration it be passed by the board by at least a two-thirds vote of all members.

Sec. 107.81. Employees.

The County Board shall appoint a clerk of the board. The clerk shall serve at the pleasure of the board. Within the appropriations available therefor, the board shall appoint other necessary board employees. In the temporary absence or temporary disability of the clerk, the Chairman of the board shall designate in writing one of the other board employees to serve as acting clerk to perform the duties of the clerk of the board, which service shall be rendered at no further or additional compensation. The clerk shall keep the calendar and records of the board in such form and manner as it may prescribe.

A complete independent audit of all financial dealings, transactions and records of the county shall be made annually. The County Board shall contract with a certified public accountant or firm of certified public accountants, to conduct such audit. Such certified public accountant or firm of public accountants selected by the board shall also make such audits pertaining to the finances of the county as may be required by the board. The complete audit shall be filed with the board and shall be open to public inspection; provided, however, that if a complete audit of the financial affairs of the county is made in any year by the state, it may be accepted in lieu of the audit required by this section.

Sec. 107.101. Authorization for the use of videoconferencing to conduct meetings.

- 1. The County Board, its committees, and its subcommittees are authorized to use videoconferencing to conduct meetings in a manner consistent with the requirements set forth in New York State Public Officers Law, Article 7, § 103-a, and subject to the following conditions:
 - a. A quorum of the County Board, committee, or subcommittee shall be physically present in the same physical location or locations where the public can attend;
 - b. Members of the County Board, its committees, and its subcommittees, at the discretion of the Chair of the County Board and under extraordinary circumstances, may participate in meetings through the use of videoconferencing from locations not accessible to the public. The County Board shall establish written procedures governing member and public attendance, and setting forth what constitutes "extraordinary circumstances" (which shall include disability, illness, caregiving responsibilities, or any other significant or unexpected factor or event which precludes the member's physical attendance at a meeting), and the procedures for the certification of extraordinary circumstances by members on a case-by-case basis. The written procedures shall be conspicuously posted on the public website of the County Board, committee, or subcommittee, as applicable;
 - c. A member experiencing an extraordinary circumstance and participating in a meeting through videoconferencing need not (i) notice the remote location from which the member participates, or (ii) allow for in-person physical attendance by the public at the member's remote location;
 - d. Any member not physically present at a meeting and participating remotely in a meeting through the use of videoconferencing due to extraordinary circumstances shall not count towards a quorum; however, a member may participate and vote through the use of videoconferencing if there is a quorum of other members physically present at the meeting in the same physical location or locations where the public can attend;
 - e. Except in the case of executive sessions, all members, including any member experiencing an extraordinary circumstance and participating in a meeting through videoconferencing, must be heard, seen, and identified while the meeting is being conducted;
 - f. The minutes of meetings involving videoconferencing must include which, if any, members participated remotely;
 - g. If videoconferencing is used to conduct a meeting, the public notice for the meeting shall (i) inform the public, (A) that videoconferencing will be used, (B) where the public can view and/or participate in the meeting, (C) where required documents and records will be posted or available, and (ii) identify the physical location for the meeting where the public can attend;
 - Meetings conducted using videoconferencing shall be recorded and the recording shall be posted on or linked to the public website of the County Board, or of the relevant committee or subcommittee, within five (5) business days following the meeting, and shall remain so available for a minimum of five (5) years thereafter. These recordings must be transcribed upon request;
 - i. If videoconferencing is used to conduct a meeting, the County Board, committee, or subcommittee, as applicable, shall provide the public with the opportunity to view the meeting through video and participate, to the extent public participation is authorized, through videoconferencing in real time, and shall ensure that videoconferencing authorizes the same public participation or testimony as inperson participation or testimony.
 - j. In person participation requirements for members shall not apply during a state disaster emergency declared by the Governor of New York, or a local state of emergency proclaimed by the Westchester County Executive, if the County Board determines that the circumstances necessitating the emergency

declaration would affect or impair the ability of the County Board or its committees to hold in person meetings.

2. Severability. If any clause, sentence, paragraph, section, or part of this Local Law shall be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair, or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, section, or part thereof directly involved in the controversy in which such judgment shall have been rendered.
