The **Pride in Parks Inspection Program** monitors the conditions, quality of maintenance and operational procedures at all PRC facilities. An inspection evaluates a site with the concept of a facility in its optimal condition. A score below 85 is considered a failure. Every facility is inspected at a minimum of once a year.
