Rate change for county employees in Tier 6 of the NYS Retirement System

Effective with the April 11, 2013 pay, some Tier 6 employees may see a change in their NYS Employee Retirement System (NYSERS) contributions. From April 1, 2012 - March 31, 2013, Tier 6 members contributed three percent of their gross salary toward their retirement benefits. However, starting April 1, 2013, the contribution rate will be based on annual wages. Future salary changes may affect your contribution rate.

Chapter 18 of the Laws of 2012 that created Tier 6 requires variable contribution rates effective April 1, 2013. The rates range from three to six percent and are based on the member's annualized wage as provided by the employer.

| Annualized Wages | Contribution Rate |
|--------------------------|-------------------|
| \$45,000 or less | 3 percent |
| \$45,000.01 to \$55,000 | 3.5 percent |
| \$55,000.01 to \$75,000 | 4.5 percent |
| \$75,000.01 to \$100,000 | 5.75 percent |
| More than \$100,000 | 6 percent |
