Since I first took office as County Executive in 2018, the health and wellness of every Westchester County employee has remained at the forefront of my mind. Life gets hard, and I want to make sure each of you is making your own self-care and well-being a top priority.

Beginning on August 1, we will be rolling out a new [Westchester County Employee Assistance Program \(WCEAP\)](#). As you know, your WCEAP provides free and confidential counseling and referral services for a wide range of concerns, including mental health issues, parenting and family stresses, traumatic events, eldercare support, financial counseling, childcare, loss and grief services and more. **Through UMR/Optum, WCEAP will be expanding its offerings and accessibility, making help available to you 24 hours a day, seven days a week via phone, online and text.**

Included in your WCEAP benefits for yourself, your spouse and your family members at no additional cost to you are the following services:

- Unlimited telephonic access to licensed counselors
- Up to three one-on-one sessions, per issue, per year, with a licensed counselor, either in person, virtually, or text-based therapy
- Talkspace Mobile App
- Financial coaching from experts
- Legal counseling and mediation services
- Self-Care: a self-paced digital program that can help members with worry, stress and mood
