
#### Introduction

To optimize emergency planning efforts for the 2022 Kensico Music Fest and Fireworks a contingency plan was developed to provide clear and concise guidelines in response to an unforeseen events or large scale emergency.

The safety and security of the event attendees and the emergency response personnel's supporting the event is of prime concern. To best coordinate a unified and coordinated response all personnel shall follow the guidelines.

The **activation** of the Contingency Plan will be coordinated through the Incident Command Post. All participants will be notified over the radio that the plan has been put in place. At this point, units assigned to an alternate role during the contingency activation should report to the predetermined location.

Although communications may be chaotic all responders shall monitor the assisted or directed radio channel and report to the assigned branch director(s). Limit radio traffic unless urgent and use direct and concise messaging.



## Resource Management & Contingency Staging (LE/Fire/EMS)

The Unified Command structure will determine the need for mutual-aid resources based on the incident type and additional resources being requested.

#### Special Resource Requests:

If required any special response asset will be required, the request will be made by the ICP. Specific staging or response information will be provided at that time. (EG: HDU, METU, Etc.)

#### **Staging Areas**

In the event that mutual aid resources are required, a Staging Area will be selected and announced to Incident personnel in-coming resources. A STAGING AREA MANAGER will be assigned to manage the police, fire and EMS resources.

<u>Staging Area Manager (STAM)</u>: The first arriving Law Enforcement officer arriving at the Staging Area will be the designated STAM and direct units to the required location upon request. Additionally, the Fairview Fire District will be notified and requested to provide supporting staff. (The Fire Branch Director will request through 60 Control the assistance of the Fairview Fire District.)

Staging Area: The **primary** Staging Area designated for a large mutual aid response will be at the Westchester Community College parking lot #11 (East Gate Entrance is located on Grasslands Road (Between Tecumseh Avenue and Lewis Ave). Appendix C – Staging Area Layout – Westchester Community College

<u>Primary Access From WCC to Kensico Dam</u>: (Appendix D – WCC Staging Area Access/Egress *to/from the incident*) The primary access to the Kensico Dam from the Staging Area will be to:

- Right (east) on Grasslands Road
- Left (north) onto Legion Drive
- Right (east) onto Broadway

<u>Primary Egress from Kensico Dam</u>: (Appendix D – WCC Staging Area Access/Egress *to/from the incident*) EMS units transporting patients to area hospitals will follow:

- Taconic State Parkway (TSP) North
- Left onto Lakeview Avenue
- Left onto Bradhurst Avenue
- Right onto 100c to the Sprain Brook Parkway (North or South depending on destination facility)

<u>Secondary Access from WCC to Kensico Dam</u>: (Appendix D – WCC Staging Area Access/Egress *to/from the incident*) The secondary access to the Kensico Dam from the Staging Area will be to:

- Right (east) on Grasslands Road
- Left (east) onto Virginia Road

- Left onto Route 22 (north) veer left onto North Broadway
- **Special note:** in the event that the "Secondary Evacuation" location is activated, the Secondary Access shall be utilized.

<u>Secondary Egress Kensico Dam</u>: (Appendix D – WCC Staging Area Access/Egress *to/from the incident*) EMS units transporting patients to area hospitals will follow.


- Right (south) onto North Broadway
- Veer Right (south) and continue on North Broadway until I-287.
- I-287 can be accessed East or West to the designated hospital assigned.

Alternate Staging Area: (Appendix E – BOCES Staging Area Access/Egress) The alternate Staging Area, in the event the above noted location is unavailable or undesirable, will be at the BOCES Campus off of Route 22 & Old Orchard Street in White Plains (North or the Dam Access Road). Additionally, the West Harrison Fire Department, supporting North White Plains Fire Company, will be notified and requested to provide supporting staff by the Fire Branch Director.

#### **Emergency Alerting & Public Information**

#### **Alerting & Public Information Strategy**

Issuance of public warning and information, in addition to media facilitation shall be coordinated through Unified Command and the incident Public Information Officer. The following provides an overview of the roles and responsibilities:



#### **Public Alerting/Information Tools:**

Public warning and information message content shall be approved by the Incident/Unified Commander(s).

- Event Public Address System (accessed via stage; and possibly remote via ICP)
- Social Media (Parks Department, OCE Communications Office).
  - Parks Twitter Account for event notifications.
- DES Voice Star Variable Message Sign and associated 1610 AM radio station (programmable):
  - Refer to the Evacuation section of this plan for pre-scripted Evacuation public address messages.
- Wireless Emergency Alerts (cellular mass broadcast):
  - Onsite Facilitator: Event Planning Section (WCOEM staff);
  - <u>Via:</u> New York State Watch Center, 518-292-2200. NYS Watch Center has been provided the following information in advance of the event:
    - Location: Kensico Dam Plaza

#### **Pre-identified Media Staging Areas**

The following locations have been pre-identified to support implementation in the event required. The actual selection will factor; incident impact and access, safety and security of survivors, responders and media personnel; and media requirements.

- Metro North Rail Parking Lot
- North White Plains Library

 Hudson Valley Transportation Management Center



Note: Media is on site for the event and should be provided with safety instructions and located appropriately.

#### Site Evacuation

The Kensico Music Fest & Fireworks draws between 10,000 and 18,000 attendees. Due to the unique design of the Kensico Dam Plaza, parking onsite is limited on the two grassy areas located directly south of Kensico Plaza, with supplementary parking made available at select fields located in proximity to the Park. In addition to vehicle traffic, attendees enter and exit the area on foot from the east, west and south.

To activate this element of the Contingency Plan, the ICP will request a radio announcement to all first responders that the Contingency Plan is now in effect and the selected evacuation route/s. Communication Unit will trigger the AM Radio message, Parks will trigger the social media message, the EOC will trigger Wireless Emergency Alerts.

#### **Evacuation South (Primary)**

In the event of an emergency evacuation, attendees will be directed via remote Public Address system to exit the Plaza on foot and walk on the northbound side of the Bronx River Parkway approximately 2,500 feet to the Assembly Area (Primary), located at the Virginia Road baseball field to the north of the intersection of Bronx River Parkway and Virginia Road.

PUBLIC ADDRESS MESSAGE: ALL EVENT PARTICIPANTS PLEASE EVACUATE THE PARK BY WALKING SOUTH ON THE BRONX RIVER PARKWAY. ASSEMBLE AT THE BALL FIELD AT THE INTERSECTION OF VIRGINIA ROAD.

Traffic Control Points at Broadway and Park Drive East, as well as Broadway and Taconic State Parkway, must control pedestrian traffic and direct attendees south on the Bronx River Parkway.

Reference Appendix F – Evacuation South Route, Primary – Pedestrian Foot Traffic

#### Evacuation North (Secondary)

In the event that the South evacuation route is not available or an alternate route is required, all pedestrian traffic should be directed north on the Taconic State Parkway (northbound lanes) and gather away from any direct danger. Lakeview Avenue should be closed at the TSP to maximize pedestrian safety.

PUBLIC ADDRESS MESSAGE: ALL EVENT PARTICIPANTS PLEASE EVACUATE THE PARK BY WALKING NORTH ON THE TACONIC STATE PARKWAY. ASSEMBLE AT THE LAKEVIEW ROAD INTERSECTION.

Reference Appendix G – Evacuation North Route, Secondary – Pedestrian Foot Traffic

#### Mass Casualty Incident (MCI) Strategy

The goal of the Kensico Music Fest & Fireworks MCI Strategy is, through a Unified Command structure, to provide efficient, timely and appropriate pre-hospital medical care and transportation of the sick and injured to appropriate hospitals. This requires a timely transition from special event mode to MCI mode and knowledge of the transition by all parties involved.

As the event is transitioned, so must the control of EMS resources. In the occurrence of any large-scale event that may occur, an expanded Medical Branch structure will be instituted with the intent of mitigating such an event.

<u>Pre-staged resources</u> will be reconfigured as necessary to assist patients on site. Apparatus/Equipment will be staged on site as follows: (Appendix H – Onsite Apparatus/Equipment Locations)

- Westchester County DES MCI Trailer will be staged in the North/West area of the outer parking area (oval);
- (1) ALS ambulance will be staged to the east of the Command Post;
- (1) BLS ambulance will be staged inside Kensico Plaza near the Healthcare Facility;
- (1) EMS UTV will be staged inside Kensico Plaza to reach difficult access locations:
- (1) EMS UTV will be staged to the east of the Command Post to reach difficult access locations.
- Each of the above units assigned a "Blast Bag" for the duration of the event.

Requests for mutual-aid will be coordinated through the Incident Command Post (ICP) by the Medical Branch Director.

**MCI Levels:** (Rule of thumb – 1 ambulance for 2 casualties)

Level:	Pt. Count:	Ambulances:
Level 1	3 - 10	2 - 5
Level 2	11 - 25	6 - 13
Level 3	> 25	13 +

**MCI Trailers**: Request additional MCI trailers for every <u>additional 25 patients</u>.

**Bus Transportation:** The use of mass transportation resources should be considered for large numbers of walking wounded (Green Patients). If a bus(s) is required a request should be made to the ICP.

**METU:** The City of Yonkers has a Medical Evacuation Transportation Unit (METU) available for large medical events. The unit can provide transportation of stable sitting and supine patients and can be requested through the ICP.

#### **Medical Branch Operations**

#### Triage:

The closest EMS response team will be dispatched to identify any potential event. These teams will ensure proper scene assessment and assure scene

safety for any subsequent responders, and relay to the ICP the number of patients, potential origin, and immediate resources needed. The first arriving unit must immediately take appropriate actions for personal safety and make immediate Personal Protective Equipment (PPE) recommendations for all responding emergency services personnel.

The Healthcare Facility (HCF) lead will assume the role of TRIAGE UNIT and immediately begin triage using the START/JUMP START triage protocol. The Triage Unit Leader will determine a safe area for walking wounded and psychologically injured to congregate and immediately liaise with Fire and Police regarding the potential for decontamination of victims.

Additional personnel resources as they become available (i.e. EMS, Medical Reserve Corps, fire, etc.) will be assigned in teams of two to assist in triage accordingly.

 NOTE: In the event the HCF leader is unavailable, the first arriving EMS Responder (EMT or Paramedic) will assume the Triage Unit Leader role

#### Treatment:

The EMS UTV 1 unit will assume the role of TREATMENT UNIT and will establish operations at the location identified on the Contingency Plan Site Map as the Treatment/Triage Area, which is at a safe distance from the incident. The Treatment Area chosen should take into account accessibility to arriving transportation resources, wind direction and the potential for decontamination of victims.

Additional personnel resources as they become available (i.e. EMS, Medical Reserve Corps, fire, etc.) will be assigned to assist as needed.

 NOTE: In the event EMS UTV 1 is unavailable, the second arriving EMS Responder (EMT or Paramedic) will be designated as Treatment Unit Leader.

#### Transport:

The EMS UTV 2 unit will assume the role of TRANSPORT UNIT to coordinate the dispersal of patients to hospitals. The Transport Unit should have the ability to communicate with the ICP, Medical Branch Director, Operations, and the Staging Officer. The Transport Unit Leader will track the number of and status of all patients transported to each facility. The Transport Group Supervisor will, in conjunction with the Medical Branch Director, ascertain bed availability from all local Emergency departments and, based on that information and patient condition, make appropriate destination decisions. The Transport Group Supervisor will, in conjunction with the Medical Branch Director, notify hospitals of transport of patients to their facility.

#### **Patient Tracking:**

Triage Tags will be made available to the on-site Healthcare Facility, MCI Trailer, and each ambulance. Triage Tags must be used for all patients transported to the hospital and should be initiated by the Triage Officer and updated by the Treatment and Transportation Officers as necessary. Additionally, all patients shall be tracked utilizing Appendix A - EMS Patient Transport Log.

#### **HELI-SPOT:**

In the event transportation via helicopter is determined necessary, the following locations have been pre-identified however request for the resource, and activation/use of these locations must be coordinated through the ICP:

Primary location: WCC Baseball Fields

<u>Alternate location:</u> Pat Henry Baseball Field S. Kensico Ave west of parkway.

#### Rescue Task Force (RTF):

In the event that incident conditions necessitate warm zone operations to provide life-sustaining care, Incident Command may activate the pre-designated RTF members, consisting of Law Enforcement, Fire and EMS personnel, including the RTF leader, filled by the designated Law Enforcement officer. The RTF will be deployed through the Operations Section, specifically coordinated by the Law Enforcement and Medical branches.

The RTF shall consist of the following staff, all having previously participated in the DPS/DES RTF training:

- (2-6) Law Enforcement personnel
- (0-4) Firefighters
- (2-6) EMS providers

The equipment for the fire and EMS RTF members shall be as follows (at a minimum):

- (1) Blast bag backpacks (pre-staged at each of the rally locations)
- (2) Skeds (pre-staged at each of the rally locations)
- (1) Portable radio
- Armband designating RFT team (if multiple RTFs activated)

If activated, members will marshal in designated (or announced) location to be briefed on situation and RTF operations specific to the incident.

The predesignated areas are as follows (Appendix I – Rescue Task Force Rally Locations):

- RTF 1 (Color Yellow) Rally location is the traffic triangle east of the circle (Ramp from Circle to Rt. 22)
- <u>RTF 2</u> (Color Green) Rally location is the construction yard adjacent to Park Drive East.
- <u>RTF 3</u> (Color Blue) Rally location is the trailer storage parking lot inside the park.

#### Fire Suppression and Water Supply

Fire suppression activities will be handled as necessary by the Valhalla and North White Plains Fire Departments and will be supplemented by the Westchester County Department of Emergency Services. Appropriate personnel and equipment will be on site from 5:00PM to 11:00PM.

Apparatus will be staged on site as follows: (Appendix H – Onsite Apparatus/Equipment Locations)

- (1) Tanker will be staged between Park Drive East and the Command Post;
- (1) Engine will be staged between Park Drive East and the Command Post;
- (1) Engine will be staged inside the Kensico Plaza behind the food vendor station to the left of the reflecting pool;
- (1) All-terrain vehicle/pumper will be staged at the southern end of the Kensico Plaza to reach difficult access locations.

#### Hazardous Materials and/or Devices

Incidents involving the potential, perceived or actual chemical, biological, and/or radiological agent release will necessitate the dispatch of the appropriate agencies to respond.

<u>On-site HazMat Resources:</u> (Appendix H – Onsite Apparatus/Equipment Locations)

- Westchester County Hazardous Materials Response Team liaison.
  - (1) Fire/HazMat UTV will be staged inside Kensico Plaza to reach difficult access locations;
  - Additional resources requested for response upon request
- Westchester County Police Hazardous Device Unit.
  - (1) HDU Truck (small) will be staged inside Kensico Plaza;
  - o (1) HDU Truck (large) will be staged near the command post;

**Environmental Monitoring** Meters will be deployed during the event to monitor for the following:

- Alpha, Beta and Gamma Radiation
- Combustible Gases
- Oxygen Level, Carbon Monoxide
- Hydrogen Sulfide
- PID meter (Volatile Organic Compounds)
- Chem-Pro (WMD agents / Toxic Industrial Chemicals)
- Chlorine

#### **Gross Decontamination:**

As the event dictates or upon request of the Incident Commander, a gross decontamination corridor will be established.

- A smaller scale gross decontamination corridor can be established by using one of the two staged engines along Park Drive East (just south of the Kensico Dam Plaza entrance)
- A larger scale gross decontamination corridor can be established using onsite Fire resources and hydrants in the following areas:
  - North Broadway at the Holy Name of Jesus Church
  - BRP (North) at Washington with master stream fog nozzle.

#### Active Killing (Active Shooter) Incident

If an event occurs which involves the active killing of victims; law enforcement's primary focus will be to isolate, distract and neutralize the threat. This includes an attack with any weapon including firearms, knives, vehicles, explosives, et cetera. The speed and definitive response by law enforcement is paramount.

- NOTE: Event personnel not engaged in the above operations should take emergency lifesaving actions such as Run (Avoid), Hide (Deny), or Fight (Defend).
  - These actions may include finding a safe location with considerations for cover (ballistic protection)/concealment (visual protection) as appropriate to the circumstances.
  - Where possible, similar instruction/guidance should be provided to attendees and other event staff not engaged in the event management/emergency response.

Once the killing has been stopped, the focus will be turned to medical response to treat the injured and prevent mortality from their wounds where possible. This will be accomplished by the actions detailed in the *Mass Casualty Incident (MCI) Strategy* section of this plan, which may include the integration of police, fire and medical services.

#### Friends & Family Reception Center

#### **Planning Assumptions**

- In an emergency that results in evacuation, friends and family that arrived together will be separated and will need to be reunited.
- In an emergency that results in mass casualty/mass fatality, friends and family who were not at the event will come looking for people they cannot contact.
- In an emergency that results in evacuation, event attendees may lose access to their cars as the area becomes a crime scene or the vehicles are damaged.

#### Friends & Family Reception Center (FFRC) Location

- <u>Primary FFRC Location:</u> Westchester Community College (West Gate Entrance)
- Secondary FFRC Location: TBD

If an alternate is required, the selected location should be near the scene but far enough away not to be directly impacted.

#### **Public Information Coordination:**

When activating this location, public information must be coordinated with the PIO, Parks, DPS and the Office of the County Executive:

- Media release notifying friends and family looking for someone to not go to the scene, but to go to the FFRC.
- Use United Way 211 as a Public Inquiry Call Center and establish a liaison between the PIO and 211.

#### Incident & FFRC Communication/Coordination

- Establish a liaison between Unified Command, the FFRC and a liaison to the Hospitals for the purpose of information exchange and family reunification.
- Staff the FFRC with law enforcement (security and detectives), Red Cross (family reunification) and DCMH (Psych Emergency Response Team).

#### **FFRC Support Services/Extended Operations**

- The FFRC is setup immediately after the emergency. A decision is then made if the services need to be expanded and to operate a Family Assistance Center (refer to County FAC Guide).
- Transportation assistance/support:
  - Establish a bus(es) that could be used to transport evacuees, who no longer have access to a vehicle, to the FFRC or some other location to await pickup by friends or family
  - Establish a liaison between Unified Command and DPW/T who can contact Liberty Lines to deploy buses, as needed
  - The buses should either be accessible to people with disabilities or a paratransit van requested specifically for this purpose




**Appendix C – Staging Area Layout – Westchester Community College**










Appendix G - Evacuation North Route, Secondary - Pedestrian Foot Traffic
