It is time for "Aflac Open Enrollment." **Starting now through 12/15/2023.** If you miss this enrollment, you will not have another opportunity until next Open Enrollment.

Current Aflac policyholders can make changes, upgrades and additions to their policies at this time.

Note: If you are a policyholder and do not need to make any changes, you do not need to talk to an agent. **Your policy automatically renews each year unless you change it.**

Retirees can transfer their Aflac policies to direct pay, if they would like to keep them.

New Employees may want a full presentation of benefits offered. We will be assisting all claims as well.
